## **Interdisciplinary Foundations of Media Theory**

This course provides an introduction to scholarly theories of media and information, with a focus on *how to read, understand, and use* scholarly theories. It is organized more to help you develop your own capacities to make sense of theories than it is a comprehensive summary of all theories relevant to the field. Because Media Studies MA students are expected to conduct a research project under the supervision of a FIMS faculty member, many of the readings are by FIMS faculty members, and many of the theories discussed will be intended to help you better understand the scholarship of FIMS faculty.

It may help to know that I believe that scholarship emerges from and is responsible to its past, its historical context. I find it useful and sometimes necessary to read works that are decades or sometimes centuries old. You'll notice that some of the readings are not the most current; that's on purpose.

Assignments will include an essay (20%), guiding a class discussion (15%), class participation and weekly reading reactions (20%), and a term paper (45%). (More details are below and online.)

What will the class be like? This class is a seminar; I will occasionally lecture a bit, but most of what happens will involve discussion, and students will have some responsibility to help generate and sustain discussion. Of course, we'll be wearing masks and maintaining social distancing, and our communications outside class will be constrained mostly to the electronic. So it's an experiment, a strange and challenging situation for all of us. It will take some patience, effort, flexibility, and mutual respect all around to make it work. We may have to make mid-course corrections and changes to adjust for unanticipated issues, small or large. But I will do my best to make this a rich, engaging, and rewarding exploration of an important crossroads in the world of ideas, and with a little help from you, I suspect it will work.

#### Assignments

• **Essay**: In a roughly 1000 word essay, explicate the theory or theories, explicit and implicit, of one or more of the articles in the collection of FIMS faculty scholarship on the recommended reading list (and which is not one you are writing about in Prof. Quan-Haase's course on methods). Due on or before the date the article is listed on the syllabus. (Sign up before the second class.) 20%

- **Guide a class discussion**: twice during the semester, you will guide a class discussion of one, or in a few cases if they are short, two of the required readings during the semester. We will sign up for these on the first day of class. 7.5% x2 = 15%
- **Participation and weekly reading reactions**: thoughtful participation in class discussion is an expectation, and to help with that, you will be required to post 8 short reading responses (approx. 250 words) to the discussion board on OWL by midnight the day before the relevant class. (These will not be graded individually, but will contribute to your overall discussion grade.) 20%
- **Term Paper**: All students will write a term paper of approximately 5000 words focused on a particular a theoretical dispute or problem area in a media studies sub-field. The paper will be presented to the class on Dec. 11<sup>th</sup>, the last day of class, and the final draft is due Dec. 16<sup>th</sup>. 45%
