Course Description

This course examines genealogy as a social, cultural, and commercial phenomenon, while providing students with a basic primer in genealogical research. Topics examined include: locating and evaluating primary sources (e.g., parish/census records) using databases like ancestry.com and familysearch.org; "Genealogy Inc." and the rise of Ancestry; community formation and genealogical practice; ancestry and nationhood; forensic genetic genealogy; DNA testing; Indigenous identity and genealogical practice; and television shows like "Finding Your Roots" and "Who Do You Think You Are."

Learning Outcomes/Objectives:

The course will enable students to: conduct original genealogical research; lead weekly discussions based on course readings; conceive, research, and write a course paper (12-15 pgs.) using extensive secondary and primary sources. Students taking this course will acquire a deep-seated understanding of the techno-informational, cultural, and social contexts and consequences involving genealogical practice since the late 20th century.

Enrolment in this course is restricted to graduate students in FIMS graduate programs.

Course Materials

There's no required text. All readings are available on-line. You will need to purchase a subscription to Ancestry.ca (approx. \$85 for six months)

Class Format

This is a discussion seminar class. While at times I may lecture a little, the bulk of the class consists of weekly discussions of selected readings and other texts. Be prepared to discuss the assigned readings in light of argument/persuasiveness; type & use of evidence; empirical and/or theoretical approaches; and relation to other readings. Each student will lead the seminar discussion at least once.
