Course description

Development of a public service mindset. Understanding of the organization of public libraries, the role of library boards in their management, and the effect of organizational structure on their services. Exploration of community structure, dynamics, and attitudes towards the public library and its potential to serve the whole community, including special client groups. Examine current political and cultural issues affecting public libraries.

Upon successful completion of readings, assignments, and class participation, students will be able to:

- 1. Develop public service-oriented attitudes.
- 2. Understand the organization of public libraries, the role of boards in their management and the effect of organizational structure on service.
- 3. Critically evaluate community structures and dynamics in order to determine the library's role in the community and to analyze its response to changing community needs.
- 4. Demonstrate awareness of, and analyze, current issues, trends, challenges, and opportunities in public libraries.

Course Format

This course is asynchronous. Course content will be posted every Sunday and students will receive an announcement in their email when the content is posted. Students are expected to login to the OWL site to complete assigned readings, post on the weekly forum and review the slideshow and/or video presentations.

Course Materials and Readings

All materials will be available electronically via OWL, or available freely online.

There is a document posted in OWL called LIS9610 Weekly Readings which lists each week of required readings. I will post this in the module as well.

Methods of Evaluation

Evaluation will be based on the following assignments and participation. All due dates are posted in the schedule above and are subject to late penalties without prior extension requests. Assignments will be reduced 2% per day if submitted late.

1. Participation via weekly forum posts (20%)

Participation for this asynchronous course will be based on weekly forum posts. You are required to respond to a weekly forum question. Your forum posts should be approximately 300 words in length and you are to respond to at least one of your classmates' posts as well with a thoughtful response.

2. Reading Reflections (15% x 2)

Choose any assigned reading and write a 2 page, double spaced, size 12 font reflection. Please do not summarize the article but instead write your own reflection upon the material as a personal response. List any references including the paper/article written about in the reflection.

3. Program Outline (20%)

Write a 2-3 page program outline for a program suitable for the public library. This assignment can be presented as a chart, a formal report, a powerpoint, or some other creative outlet. This program can be for a specific audience or open to everyone. The idea is to create a program idea to present to library management through a comprehensive outline.

4. Current Issues Paper (30%)

Write a paper which focuses on a current issue facing public libraries. Feel free to email me the topic in advance to check whether the topic is relevant. The paper should be no more than 7 pages double spaced, size 12 font, with at least 5 references.
